**THIS NOTICE PROVIDES IMPORTANT INFORMATION REGARDING  
SANTA FE AUTO INSURANCE COMPANY (“SANTA FE”)**

**Santa Fe has been placed in receivership for liquidation.**

On April 5, 2013, the 419<sup>th</sup> District Court of Travis County, Texas entered an *Order Appointing Liquidator and Permanent Injunction*, placing Santa Fe into liquidation under Chapter 443 of the Texas Insurance Code. The Court appointed the Texas Commissioner of Insurance as Liquidator. The Liquidator appointed CANTILO & BENNETT, L.L.P. as the Special Deputy Receiver (“SDR”) of Santa Fe.

**Santa Fe’s policies have been cancelled.**

All insurance policies issued by Santa Fe were cancelled no later than May 5, 2013, as required by the Texas Insurance Code. Notices of cancellation were previously provided to Santa Fe’s policyholders of record.

**Guaranty associations are paying “covered claims” under Santa Fe policies.**

If you have a claim under an insurance policy issued by Santa Fe, you may have a “covered claim” that is payable by a state insurance guaranty association (“guaranty association”). Information regarding the Texas Property and Casualty Insurance Guaranty Association is available at [www.tpciga.org](http://www.tpciga.org). Links and contact information for other states’ guaranty associations are available on the SDR’s website.

**Claims not paid by guaranty associations may be filed in the Santa Fe receivership.**

You may file a Proof of Claim (“POC”) in the Santa Fe receivership for any amount due from Santa Fe that is not covered, in whole or in part, by a guaranty association. **POCs must be received by the SDR no later than 11:59 p.m. CDT on October 5, 2014.** POC forms may be obtained as follows:
